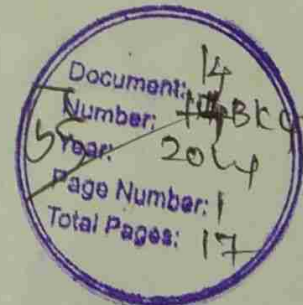
THIS DEED OF TRUST made on this 24th day of MAY, 2014 at MELUR by A.SATHAKKATHULLAH, S/O P.ABDUL KAFAR resident at 10/10 Elango main road vellanathan patti melur(t.k) Madurai (d.t) hereinafter called **FOUNDER OF THE TRUST**.

WHEREAS THE FOUNDER OF THE TRUST possesses and absolutely own of Rs. 1,000/- and is desirous to establish a **Charitable Trust**, wholly for charitable purposes and more specifically for providing **EDUCATIONAL & SOCIAL WELFARE SERVICE** to the deserving People in India.

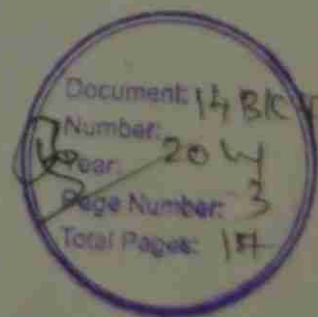

Whereas the above named persons hereinafter called as the **TRUSTEES** of the trust (which expression shall include Trustee unless repugnant to the context or otherwise),

AND WHEREAS the *Trustees* above named have agreed individually and collectively to act as such and already taken possession of the said cash assets in pursuance of the aforesaid desire of the **FOUNDER OF THE TRUST** who has irrevocably transferred and handed over the same to the *Trustees* for the purpose of the Trust as aforesaid.

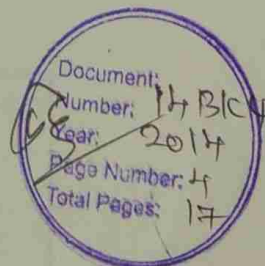

NOW THIS INDENTURE OF THE DEED OF TRUST declares and witness:-

1. That in pursuance of the premises, the Founder of the Trust as settler doth hereby convey unto and settle upon the *Trustees* all the cash to hold the same upon and the *Trustees* do and each of them doth hereby admit and acknowledge the *transfer* thereof to them with powers and subject to the uses mentioned hereinafter.
2. The name of the Trust shall be "ARRAHMAAN SOCIAL WELFARE TRUST."
3. At present, the registered office of the trust will function in the *rental building* leased premises at 10/10 Elango main road vellanathan patti melur(t.k) Madurai (d.t)
4. The Trust has been established for the sole and only purpose and object of providing Educational and Social welfare Service to the deserving People in India regardless of the consideration of the caste, creed or religion to which any people belongs. The main aims and object of the trust includes;
 - a. To run a Islamic school such as Nursery, Primary, Secondary and Higher Secondary with Islamic orientation and all other College and Technical Education including Arabic Literature and all other allied educational courses to the deserving pupil especially Muslim community students in India.

b. To buy, build, construct and develop Buildings and all other infrastructures mainly necessary for running institutions.

c. To provide educational, vocational and professional guidance and impart training, coaching centers in various fields in order to rehabilitate the deserving peoples.

c. To provide mental health care, de-addiction, and rehabilitation facilities to improve the quality of life of the mentally affected.

d. To organize and conduct rural programs to improve the standards of life and health of the people.

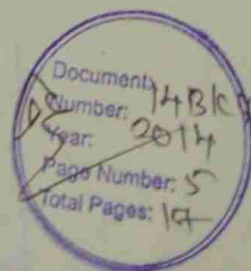
e. To provide organize, maintain, control, develop and conduct programs for the affected sections of society especially weaker section of the society at large.

f. To provide free "old age home" especially widow and aged women.

h. To establish and run 'orphanage home' for deserving peoples in India.

5. The cash hereby conveyed to the *Trustees* shall form the corpus of the trust property. But the *Trustees* shall have power from time to time to increase or decrease the *corpus of the Trust*.

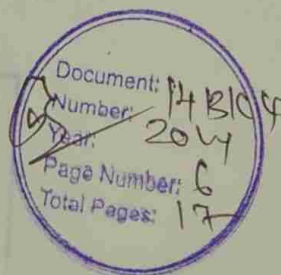


6. The *Trustees* shall stand possessed of the cash hereby conveyed and settled upon and shall use and apply the corpus of the fund, other income and other assets derived thereby for the sole purpose and object of the Trust.
7. Subject to the provisions of rules and regulations of State Government, Central Government, Government Bodies and Universities, the trust has to constitute *Educational Institutions and Charitable Institutions* to the deserving People in India.

8. BOARD OF TRUSTEES:

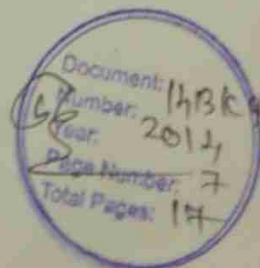
- a) The Trust shall be governed by a **BOARD OF TRUSTEES**. The Board of *Trustees* for the time being shall constitute of the *Trustees* hereinbefore mentioned which is hereby authorized and empowered to nominate any other person as *Trustees* as long as the total number of the *Trustees* including founder at any time does not exceed *five*.
- b) In the event of death, incapacity, insolvency, resignation or refusal on the Part of any Trustee to act as such, the remaining *Trustees* shall be entitled to nominate any other person as they think fit and proper to act as *Trustee* in place of the vacancy of *Trustee* as such.

- c) The nomination of any person as a *Trustee* shall be either Unanimous or by a majority decision and in the event of the *Trustees* being equally divided on the nomination of any person, the decision in the matter of nomination, the **MANAGING TRUSTEE** shall be final and conclusive.
- d) The administration of the Trust hereby constituted and the entire control, supervision, regulation, management of the Trust and trust properties and even the application of the entire or a part of the income thereof as also of all the donations and contributions and subscriptions, if any, received by it, shall vest in the uncontrolled discretion of the **Board of Trustees** however always subject to the provisions contained as hereinafter.
- e) The *Trustees* may at any time invite and receive or without such invitation received any voluntary contributions from any person or persons whomsoever either by way of donation or annual or other subscription or legacy or otherwise for the support or for the benefit of the Trust hereby constituted and declared.
- f) Every power, authority or discretion hereinafter or hereinbefore conferred upon the *Trustees* shall be exercised or signified either by some instrument in writing or in Minute Book to be signed by all the *Trustees* or by the resolution of a majority of the *Trustees* who shall be present and vote at a meeting of the Board of *Trustees* provided that notice of intention to hold such meeting shall have been

given to all the *Trustees* and provided that not less than two of the *Trustees* shall attend and vote upon the question to be decided by the resolution. The Managing Trustee or Chairman of the meeting shall have a second or casting vote in case of an equality of votes for and against any resolution.

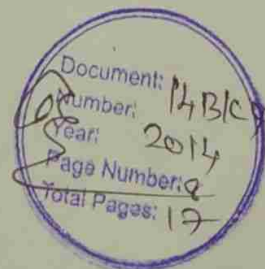
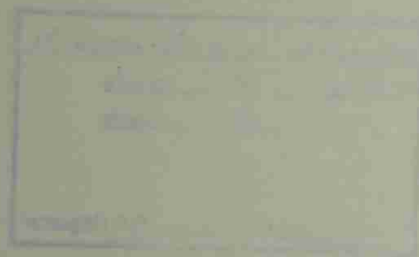
9. **MANAGING TRUSTEE:**

The Board of *Trustees* may elect or nominate any one of them as the **MANAGING TRUSTEE** for any period of time, but the first **MANAGING TRUSTEE** shall be **A.MOHAMMED FAROOK**, and he shall hold office for a period of three year. He is eligible for re-appointment if the Board of Trustees decided as such by a single majority.

10. **FIRST MEETING :**

The first meeting of the Board of *Trustees* shall be held within three months of the date of the execution of this deed and shall be summoned by the founder of the trust by giving at least seven days' notice in writing to all the *trustees* to be held at such place and time as may be specified in the notice, and in that meeting all relevant matters relating to the trust shall be considered in all possible details and particularly the ways and the manner to give effect to the provisions of the Deed of Trust and to attain the object and purpose of this Trust.

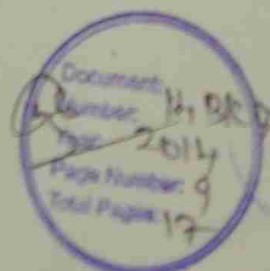
11. SECRETARY :

The *trustees* are hereby authorized and empowered to appoint a secretary among the trustees to carry out the duties assigned to him in relation to the execution of this trust. However the First Secretary of the trust shall be Janab A.SHEIK DAWOOD who will hold the office as a secretary for three years. He is eligible for re-appointment if the Board of Trustees decided as such by a single majority. If any one of the *trustees* be appointed as the Secretary he shall not be entitled to receive nor shall be paid any salary. The *trustees* may also appoint such staff as they deem expedient and necessary for the purposes of the trust at such salary as they may decide in each case.

12. CASH AND BANK ACCOUNTS :

Subject to the provisions hereinbefore contained the *Trustees* shall not keep in hand either themselves or together with the Secretary and /or any other employee of the trust or any other person at any time more than Rs.5, 000/- in cash belonging to the trust fund and all cash belonging to the trust shall be deposited with the bank account of the trust itself. The *trustees* may open an account or accounts with any Bank or Banks in the name and style of the Trust. The same shall be operated upon by the Managing Trustee or any other *trustee* authorized by the Board of *Trustees* on behalf of the Trust.

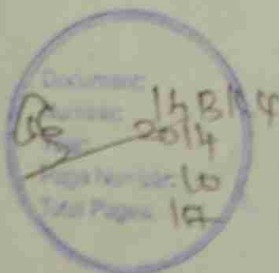
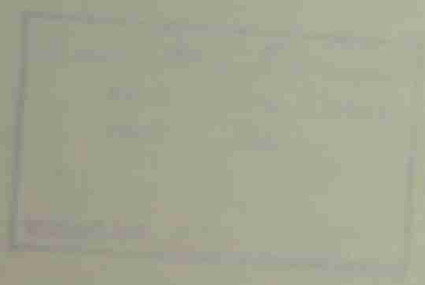
13. MEETING:

Meeting of the Board of *Trustees* may be held at such time, at such place and on such dates as may be agreed upon by the *trustees*. Such meetings may be summoned by any one or more of the *trustees* by giving at least seven days' notice in writing to all the *trustees*, specifying the time, place and the date of the meeting, and also indicating the purpose of such meeting. But a meeting of the Board of *Trustees* shall be held in every year to consider and adopt the accounts of the trust hereby constitute and the report concerning those accounts as prepared by a Chartered Accountant after an audit thereof.

14. ACCOUNTS AND AUDIT :

True and proper accounts of all the receipts and disbursements relating to the trust hereby constitute shall be kept by the *trustees*, the Secretary thereof and/or the employee(s) of the trust, who have been assigned the duty in that regard. On or after 31st day of March each year, an income and expenditure account for the whole year upto that date and a Balance Sheet of the Assets and Liabilities as on that date relating to the affairs of the trust shall be prepared. These accounts and the balance sheet shall be duly audited and examined by a Chartered Accountant, which may be engaged by the Board of *Trustees* for the purposes of such audit on such remuneration, as they may deem necessary and desirable. As soon as may be after such audit, a meeting of the Board of *Trustees* shall be held at which the accounts of the trust hereby constitute and the

report of the audit concerning the same shall be examined and adopted by resolving resolution.

15. If the **trustees** differ with one another in respect of any such matter with reference to which they enjoy discretion, the opinion of the majority of the **trustees** present and voting at the meeting shall prevail and shall be binding on all the **trustees**, and in the event of the **trustees** being equally divided the view taken by the managing trustee shall prevail in deciding such matter.
16. Subject to the conditions hereinbefore made, the trust may join in hands with any other trust, society or organizations in unique nature to fulfill the object of the trust. If necessary after the unanimous decision of the **trustees**, the trust may merge, amalgamate or adopt any other Charitable Trust to achieve the desire and object of the trust.
17. That the corpus of the trust or income or property shall not be transferred, relinquished, sold out, exchanged or otherwise dealt within a manner which shall invite the levy of income-tax on the income of the trust property.
18. That the conversion of any of the investments of the trust into any other investment shall be made in a manner determined with reference to the provisions of the Income Tax Act as in force in India so as to ensure that the income of the trust on the conversion so made continues to be fully exempt from income-tax.
19. The surplus funds of the Trust which has not been spent in any year shall be invested in the modes prescribed under relevant

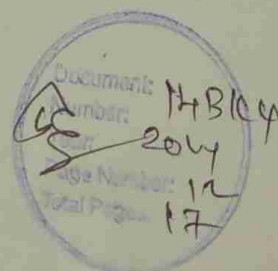
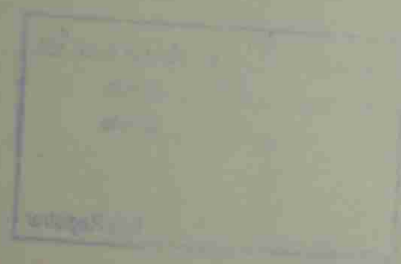

sections of the Income-tax Act, 1961, as amended from time to time.

20. The *Trustees* shall at their discretion, acquire, purchase or sell immovable properties or movable properties in the course of managing of Trust, however, any sale of immovable shall require prior consent of at least $3/4^{\text{th}}$ majority of the *Trustees*.
21. The funds of the Trust shall be spent/ utilized/ invested in the modes specified under the Income Tax, 1961.
22. No income of the Trust shall be applied for the personal benefit either of the *Trustees* or of the settler.
23. An amendment to the terms of this Deed shall be made with majority of *trustees*. However, the amendments to be carried out shall not infringe the provisions of section 2(15), 11, 12, 13 and 80G and 35 CCA of the Income-tax Act, 1961 and amended from time to time.
24. The Trust formed is irrevocable.
25. The funds/income of the Trust shall be solely utilized for achieving the objects of the Trust and no portion of it shall be utilized for the benefit of the *Trustees* by way of interest, bonus, dividend, profit, etc.
26. The benefits of the Trust shall be open to all Indians irrespective of caste, creed or religion.

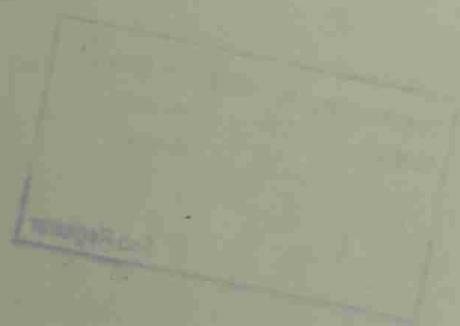

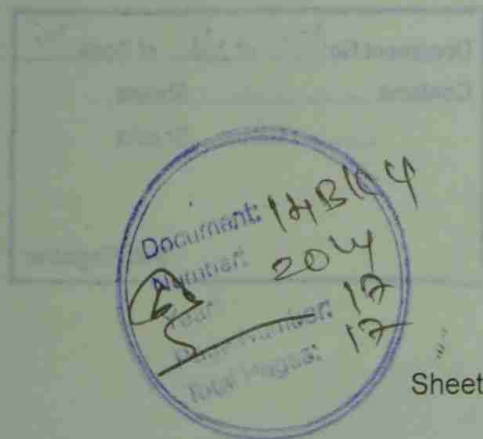
